## **Child Protection Policy of Kilbrittain N.S. 2022-2023**

The Board of Management recognises that child protection and welfare considerations permeate all aspects of school life and must be reflected in all of the school's policies, practices and activities. Accordingly, in accordance with the requirements of the Department of Education and Skills' Child Protection Procedures for Primary and Post Primary Schools, the Board of Management of Kilbrittain N.S. has agreed the following child protection policy:

4. In its policies, practices and activities, Kilbrittain N.S. will adhere to the following principles of best practice in child protection and welfare:

The school will

- recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;
- Fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters
- adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
- develop a practice of openness with parents and encourage parental involvement in the education of their children; and
- Fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

5. The school has the following practices and policies in place to support the Child Protection Guidelines:  
Code of Behavior, Anti bullying Policy, Attendance Policy, R.S.E., Internet Safety Policies.

The Board has ensured that the necessary policies, protocols or practices as appropriate are in place in respect of each of the above listed items.

7. This policy will be reviewed by the Board of Management once in every school year.
